The Global Innovation Index (GII) is a service of the World Intellectual Property Organisation (WIPO). It ranks the innovation ecosystem performance of over 130 economies around the globe. Now in its 14th year, the index highlights innovation strengths and weaknesses and particular gaps in innovation metrics. The top ten countries in the GII ranking are:

1. Switzerland
2. Sweden
3. United States of America

4. United Kingdom
5. Republic of Korea
6. Netherlands
7. Finland
8. Singapore
9. Denmark
10. Germany.

In the 2021 Report, Trinidad and Tobago was ranked 97th overall out of 132 countries but 51st in its income group and 15th in its regional grouping. *While Trinidad and Tobago has a rich and creative culture, there may be a gap in terms of overall direction, policy, infrastructure and coordinated effort where it comes to strengthening the effort and results toward innovation.*

The Index comprises around 80 indicators on which a country is scored including: measures of institutions, human capital and research,

“Survey of Science and Technology (S&T) Indicators” seeks to collect data on the expenditure and human resources dedicated towards S&T through annual surveys. S&T indicators can aid in developing policies and strategies to support the achievement of the vision 2030 goals (<https://www.planning.gov.tt/content/vision-2030>) and in international benchmarking including global indices such as the Global Competitiveness Index (GCI) and Global Innovation Index (GII) explained above. number of submissions was beyond the expectations and invalidated the original timelines for screening and evaluation. The Panel is expected to conclude its work by the end of February.

We are excited and encouraged by the projects which have been submitted. Innovation projects ranged across agriculture, agri processing, , business services, creative industries, health, ICT e-commerce platforms, manufacturing, renewable energy, sports, waste and environmental management.

The next step will be 5 weeks for the preparation of stage 2 detailed plans with support from the management firm and its team of industry specialists.
