Shaping the future of Innovation Components

Shaping the Future of Innovation is a programme of the Government of the Republic of Trinidad and Tobago, the European Union (EU) and IDB LAB in collaboration with the Caribbean Industrial Research Institute (CARIRI) as the executing agency. It aims to contribute to a diversified economic base in Trinidad

and Tobago. Funding of over Euro 8 million has been provided by the European Union and the IDB LAB to support this innovation programme in Trinidad and Tobago.

Components of the Programme

The programme comprises three components:

Component 1: The Innovation Challenge Facility. This component seeks to provide grant funding (non-reimbursable funds) to (i) small organisations / innovators / entrepreneurs, (ii) medium sized organisations with an established commercial track record (iii) other organisations / clusters innovating delivery of goods and services., to support the commercialisation of innovation. The first call for proposals was published in November 2021.

Component 2: Building Industry and Academic Linkages: This component is geared towards piloting a programme that will improve collaboration between tertiary level postgraduates and local firms in Trinidad and Tobago. In this component a


platform will be established linking postgraduates, with private sector firms seeking an intern specialized in specific areas to advance R&D /Innovation within their respective organizations.

In December last year, Europe saw the publication of the 2021 EU Industrial R&D Investment Scoreboard. Published annually since 2004, it provides indicators on investments made by EU companies in Research Development and makes interesting comparisons with global trends.

Despite a challenging economic environment, R&D investments in some sectors grew in Europe health and ICT services, which was boosted by the pandemic and was a trend we saw globally.
